Description: The products are Battery Operated by a single 9 Volt type battery, Single Station Smoke Alarms intended for wall or ceiling mounting and are also suitable for use in Recreational Vehicles (RVs).
The products are intended to detect an abnormal amount of smoke density in the area in which they are installed and to actuate the American National Standard Audible Emergency Evacuation Signal (ANSI S3.41) in response. The Alarms are comprised of resistors, capacitors, jumpers, an Application Specific Integrated Circuit (ASIC), a Piezo-electric Horn (P-Horn), an ionization (Ion) chamber, a visible LED (optional) and battery. All components except the battery are mounted on a Printed Wiring Board (PWB). The battery and PWB assembly are housed in a plastic enclosure with openings to the external environment sufficient for smoke to enter and reach the Ion chamber.
The Alarms are intended to be installed in accordance with the User's Manual instructions and the National Fire Alarm Code (NFPA 72).
